



PRESCHOOL-SCHOOL AGE INCLUSION GRANT OPPORTUNITY

Workforce Solutions Upper Rio Grande has received funding for the award of materials and supplies to assist providers caring for children with disabilities ages three (3) and over. The purpose of the award is to provide appropriate materials to assist in including children with disabilities in the daily routine of the child care program. All CCS providers who care for children age three (3) and over identified as having a disability are eligible to apply for the award. Approximately 10 awards will be made, based upon the number of CCS children with disabilities in care, and in the case of a tie, the overall number of children with disabilities in care. Application deadline is August 16, 2010 and applications should be addressed to Vera Olivas, 1600 Brown St, El Paso Texas 79902. They may be sent via email to vera.olivas@urgjobs.org, or by mail post marked on or before August 16, 2010.

Applications will be evaluated based on the enrollment of children age three (3) or over identified as having a disability and the provider's desire to better include the child(ren) in the activities of the center or home.
